Re: District GLT Quarterly Report (MD 4 GLT Measurement Tools)

This information is sent to you to clarify the desire of the Council of Governors to establish a reporting system with substance. It is requesting from you detailed information about those actions you mostly already do. The reporting system DOES ask District Coordinators to be active in ALL the areas which a District GLT Coordinator is supposed to be active and responsible (as part of the District Leadership TEAM). The "[District GLT Resource Guide](#)", which is found on the LCI website, provides guidance.

More frequent conversations with clubs will be a necessity if we (you and the MD 4 GLT) are to know if we are effective, and if we have the data to prove "How Good We Are!"

The identification of future leaders is a responsibility that, in the past, "just happened." We would now hope for you to delineate the future leaders by name and club.

A lot of the requested information fits the existing "Quarterly Report's" categories, but won't fit on the page. It is quite likely that no one form will fit all districts. Any of the requested information that doesn't correspond, would be reported as "other." So, in order to report your data, I envision that you'll need to attach a few pages reporting what you accomplished after you check the boxes on the form. It is probable that I will adjust the paper format at a later date, after you've done it once or twice and after I get your feedback. However, this is new to me, too.
